Tornado Hits Innsbrook



When the Tornado hit Innsbrook last week and the primary network service failed due to the loss of electricity, BCI’s generator ready building was one of the very few buildings in Innsbrook with electricity.

The importance of being in a ‘generator ready’ building became apparent when the violent thunderstorms tore through central Virginia, Monday afternoon, toppling trees onto homes and power lines.

The storms sent Innsbrook workers scurrying into stairways and basements and left more than 148,000 Dominion Virginia Power customers blacked out in the late afternoon. The National Weather Service called it “ a massive wind event” that rolled basically along Interstate 64, through downtown Richmond and on to southeast Virginia.
